PERFORMED HP FUEL PUMP REPLACECEMENT, DRAINED AND SAVED COOLANT, OPENED HOOD, INSTALLED ENGINE BARING TOOL ON THE BOTTOM OF THE FLYWHEEL HOUSING. SET ENGINE TO TDC #1. REMOVED: AIR INTAKE CONNECTION, ENGINE HARNESS CONNECTIONS, HP FUEL LINES, FUEL FILTER MODULE, ALL NECESSARY FUEL LINES FROM THE FILTER MODULE TO THE HP PUMP FLANGES, OEM FUEL LINES, ALL COOLANT LINES, AND HP FUEL PUMP. **NOTE, ALL STEEL BRAIDED FUEL LINE CONNECTIONS WERE SEIZED. ADDITIONAL TIME IS NEEDED FOR UNFREEZING ALL THE STEEL BRAIDED LINES.** REVERSE DISASSEMLY FOR REASSEMBLY USING NEW SEALS, GASKETS, FUEL FLANGES, HP FUEL LINES, AND COOLANT LINES/FITTINGS. VAC FILLED COOLING SYSTEM AND TOPPED OFF SYSTEM WITH COOLANT. INSTALLED THE FXP 95 FUEL PRIMER TO THE PRIMING PORT IN THE FUEL FILTER MODULE AND PRIMED THE FUEL SYSTEM. STARTED THE ENGINE AND CHECKED FOR LEAKS. - OK. NO LEAKS PRESENT. REMOVED THE FUEL PRIMER. CONNECTED THE VEHICLE TO DL8. CLEARED THE INACTIVE F/C'S FROM THE VEHCILE. UNCAGED THE 4 REAR DRIVE AXLE BRAKE CHAMBERS. PUT THE CAGING TOOLS UNDER THE DRIVERS SEAT. CONNECTED THE SUSPENSION LEVELING VALVE ARM. PERFORMED ROAD TEST IN YARD, NO PLATES ON THE TRUCK. RECHECKED COOLANT LEVEL AND FOR ANY LEAKS. - OK. JOB COMPLETE.

"LIMITED LABOR WARRANTY"

THE REPAIR FACILITY GUARANTEES THE LABOR USED IN PERFORMING THE REPAIRS LISTED ON THIS REPAIR ORDER FOR A PERIOD OF 90 DAYS OR 4,000 MILES (WHICHEVER COMES FIRST) FROM THE DATE SUCH REPAIRS WERE COMPLETED. THIS LIMITED WARRANTY SPECIFICALLY EXCLUDES: FRONT END ALIGNMENTS, ELECTRICAL WIRING AND SHORTS, AND FUEL SYSTEM - WHEN DUE TO CONTAMINATION. THIS LIMITED WARRANTY IS EXTENDED TO THE VEHICLE OWNER/CUSTOMER AND IS NOT TRANSFERABLE TO, NOR ENFORCEABLE BY, ANY OTHER PERSON, DURING THE DURATION PERIOD OF THIS LIMITED WARRANTY. THE REPAIR FACILITY WILL PROVIDE ADDITIONAL LABOR, AT NO EXPENSE TO CUSTOMERS. FOR ANY ADDITIONAL REPAIRS THAT ARE NECESSITATED AS A RESULT OF REPAIRS UNDER THIS LIMITED WARRANTY, CUSTOMER MUST: (A) NOTIFY THE REPAIR FACILITY AT THE ADDRESS SHOWN ON THIS REPAIR ORDER OF ANY DEFECT IN LABOR WITHIN A REASONABLE TIME AFTER CUSTOMERS DISCOVER OR SHOULD HAVE DISCOVERED ANY SUCH DEFECT. SUCH NOTICE, HOWEVER, MUST BE GIVEN TO REPAIR FACILITY BEFORE THE END OF THE DURATION PERIOD OF THIS LIMITED WARRANTY, AS SPECIFIED ABOVE; (B) DELIVER THE VEHICLE TO THE REPAIR FACILITY AT THE ADDRESS SHOWN ON THIS REPAIR ORDER WITHIN FIVE (5) DAYS OF NOTICE OF SUCH DEFECT IN LABOR; (C) AUTHORIZE THE REPAIR FACILITY TO MAKE THE REPAIR REQUIRED: AND (D) PAY THE CHARGES FOR ANY ADDITIONAL PARTS REQUIRED TOGETHER WITH SALES TAX UPON COMPLETION OF SUCH REPAIR. ALL IMPLIED WARRANTIES, INCLUDING THE IMPLIED WARRANTIES OF LIMITED WARRANTY. UNDER NO CIRCUMSTANCES WILL THE REPAIR FACILITY BE LIABLE TO CUSTOMER FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES, INCLUDING BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROPERTY, LOSS OF VEHICLE USE, LOSS OF TIME, LOSS OF INCOME AND PROFITS, INCONVENIENCE OR COMMERCIAL LOSS. NOTIFICATION OF CHANGES

USE OF STANDARD REPAIR TIMES

THE REPAIR FACILITY CHARGES FOR STANDARD REPAIR TIMES (SRT) OR ACTUAL TIME DURING THE COURSE OF A REPAIR. STANDARD REPAIR TIMES ARE BASED ON A NATIONAL AVERAGE OF REPAIRS AND IS PUBLISHED BY A NATIONALLY RECOGNIZED AUTHORITY ON THE REPAIR OF HEAVY DUTY TRUCKS.

AGREEMENT TO MISCELLANEOUS FEE

THE REPAIR FACILITY CHARGES A FEE OF 9% OF PARTS AND LABOR ON ALL TICKETS UP TO \$425.00. THIS FEE COVERS THE COST OF CONSUMABLE ITEMS AND THE DISPOSAL OF WASTE MATERIALS GENERATED BY THE SHOP. BY SIGNING THE FRONT OF THIS DOCUMENT, YOU ARE AGREEING TO THIS FEE.

DIAGNOSTIC CHARGE

THE REPAIR FACILITY CHARGES A FLAT CHARGE OF ONE (1) HOUR OF LABOR FOR THE INITIAL CONNECTION OF ALL DIAGNOSTIC EQUIPMENT. TIME USED IN THE REPAIR WILL BE CHARGED IN EXCESS OF THIS FEE.

RESPONSIBILITY OF LOSS ITEMS

THE REPAIR FACILITY IS NOT RESPONSIBLE FOR ANY ITEMS LEFT IN THE TRUCK. PLEASE BE SURE TO REMOVE ALL ITEMS OF VALUE FROM THE TRUCK PRIOR TO REPAIR.

STORAGE FEES

PLEASE BE ADVISED THAT UPON COMPLETION OF OUR SERVICE WORK, WE PROVIDE THE CUSTOMER WITH SEVEN DAYS OF STORAGE. WE RESERVE THE RIGHT TO CHARGE \$150.00 PER DAY FOR THE STORAGE THEREAFTER.
